## Sustainability at the core

Sustainability influences everything we do. We are actively pursuing a well-defined strategy to achieve our goal of reducing scope 1 and 2 emissions by 42% from our 2020 baseline by 2030.

## Reducing food loss and waste

Fazer has pledged to reduce its avoidable food loss by 50% by the year 2030 from the 2020 baseline. We maintain an unwavering commitment to this goal and have set and pursued long-term targets for cutting down waste in our operations since 2015.

In 2023, we achieved a 5% reduction in avoidable food loss compared to the previous year and a 5% decrease compared to the 2020 baseline

## Sustainable sourcing

To minimise environmental impacts in our value chain, we pledge that by 2025 53% of our suppliers by spend will commit to SBTi targets.

At the end of 2023, 47% of Fazer's suppliers by spend had committed to set Science-Based Targets for emission reduction, a significant stride towards our target of 53% by 2025.
